- Capt. Bostwick Dept of Fire Rescue: members assisting with vaccines at Mercedes Benz, firefights phase 1 physicals occuring, always remember the close door campaign - close your door if there is a fire, it allows them time to find you
- Major Spann Zone 5 commander APD: successful Coffee with a Cop, Dorthea won a smother and covered award for her work with Public Safety and APD, another coffee with a cop coming up, there have had many successful events, protests were peaceful and went well, they are prepping for protests related to Reshard Brooks verdicts, staying aware of any planned protest - plans to keep the neighborhood aware - Nuisance property List: Members Only night club has been added to this list - Have been conducting compliance checks with many night spots that have had complaints. - Always an uphill battle with dirt bike/ATVs on the roads- Partnered with Ga state patrol as they are able to chase them as APD does not do this - Construction sites: increase in copper theft, secure your tools at construction sites, they have a suspect (white older male), open for questions, Dorthea: what did we find at Sidebar? Sidebar had a temporary liquor license, and do not have a valid valet permit D: When did you do the inspection? A: 4/24, 4/25
 - Forrest: what is the procedure to get someone on the Nusiance list? A: We look at how many complaints, or a spike in violent crime. Forrest: that's initiated by APD not neighbors A: yes but neighbors can assist, Dorthea is a goos contact. Forrest: who is for Zone 5:
